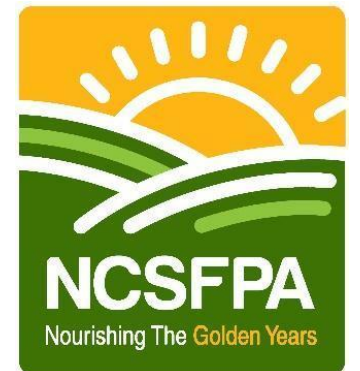
Provide a connection between local and state CSFP agencies and the USDA.

Reduced registration fee for Annual Conference (Oct. 2023)

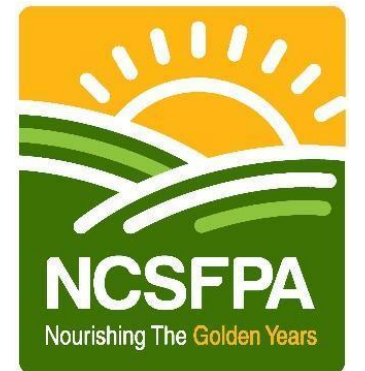


Nourishing The Golden Years

New Membership Option

The NCSFPA Board has voted to make changes to Membership Fees **beginning in 2023**.

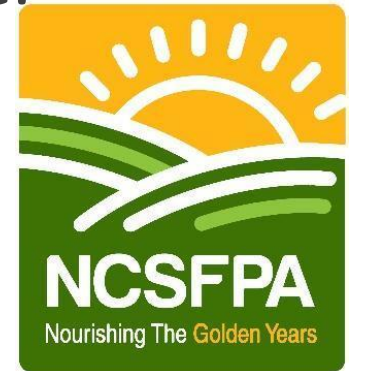
Given the stated purposes of the Association, the Board feels that the addition of a **new “State-Level Membership”** will allow State and local agencies to join NCSFPA at a reduced rate and expand the national network.



State-Level Membership

The new State-Level Membership Rate is a **simplified way to provide membership to all** CSFP agency staff within your state. This includes CSFP staff from both the State Agency and all CSFP Local agencies.

Previously, all CSFP Agencies paid a rate based on their individual assigned caseload. The larger the caseload, the higher the rate.

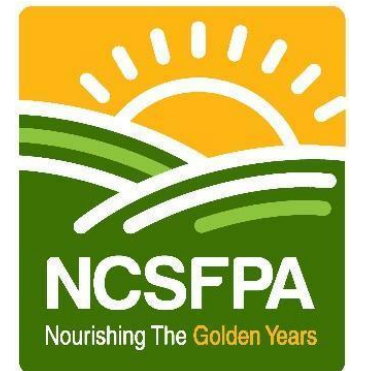
What Does That Mean?

It means that...

Your State can pay for one membership for all CSFP Agencies in your state.

A Local Agency can pay for one membership for all CSFP Agencies in your state. This may be the same as what they already were paying.

Several CSFP Agencies can pay for individual memberships that together cover a State Level membership for all state CSFP agencies.

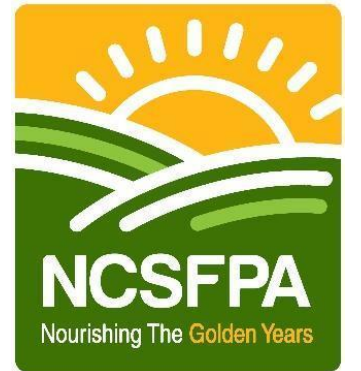


What Else Does That Mean?

It also means that...

Tribal Organizations are included in their State Level membership for their state.

Puerto Rico is included in Florida's State Level membership.

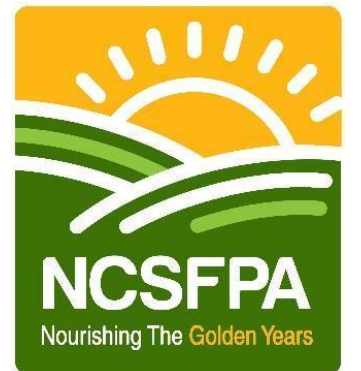


Why The Change?
