What Does That Mean?

Your State can pay for one membership for all CSFP Agencies in your state.



A Local Agency can pay for one membership for all CSFP Agencies in your state.



Several CSFP Agencies can pay for individual memberships that together cover a State Level membership for all state CSFP agencies.
